

What will happen to students if the university did not pass accreditation?

Why is this happening?

First of all, it is necessary to determine that state accreditation is a legal document that guarantees the student of the university compliance with the level of education and directions defined by the University's Charter. Such a certificate is issued to a higher educational institution for a period of 5 years, after which it is necessary to re-pass accreditation, thereby confirming its legal status.

For a student, important information is as follows: The university, in the presence of state accreditation, has all the authority to give graduates of diplomas about obtaining higher education.

Otherwise it is impossible, and 5 years of study for a student becomes aimless time. However, it is not necessary to despair, since the current legislation provided for such a development of events.

The university cannot receive accreditation for various reasons, but more often becoming gross violations in the learning or documentation process.

The university must fix all the indicated errors in a timely manner and only after that it gets the opportunity to continue its activities.

There are other options as the University's leadership.

Submit to court. Such cases are greatly rare, but in practice they are still found, are known to lawyers.

Nothing to do. In this case, the educational institution will urgently closed and not attempting to somehow change the situation.

The most important thing is to figure out what happened. The university can get a failure to accredit or its license will be suspended, canceled.

Students get to such valuable information is not easy, the only thing they receive is a written notice for 5 days about the closure of a higher educational institution. However, it is important to understand what is happening.

Limited university capabilities incurred accreditation

If the university received a refusal of a license, this is what you need to know to find the output from the current situation:

Reception of applicants continues;

Lack of opportunity to enter graduate school;

the impossibility of paying out training from maternal capital;

lack of delay from the army;

Nonresident need to search for removable housing - the hostel is not provided.

If the license is suspended, the university can continue to work, but the educational activities of students will be suspended. When the license is completely canceled, the educational institution is urgently closed. In any case, the information for the student is not the most comforting, but also despair is not worth it.

The duties of the university who did not accredit accreditation

If it happened, and state accreditation is not passed, the first part of the University's leadership should notify students about the license duty before the end of the license. The charter is specified for a period of 5 days, and this is required in writing.

This is a paramount task, but there are other, no less relevant in the current situation:

ensure trouble-free translation of the student into other universities with state accreditations for the selected specialty;

guarantee equivalent conditions for obtaining higher education in another educational institution;

in writing to arrange an order for the contribution of students from one university and also writing their further translation into another higher education institution;

Submit lists to a new university about students who plan to translate in their walls of a similar specialty;

Provide a copy of the approved wounds of curricula, personal affairs of students to a new university.

Make it all is necessary in the shortest possible time, so that the student can continue learning without breaks. If any disagreement or "pitfalls" arise, questions to solve already in legal order.

Responsibilities of a student

If the student of the university, upon receipt of news, the refusal of accreditation believes that everything is in order, and everything will be solved for it, it is very mistaken. It is necessary to fuss.

His duties include the following aspects:

Write a written application for the name of the rector on the transfer to another university for the same specialty;

To learn a student card, because in case of refusal of the university in accreditation, it is still considered invalid, and the student benefits are no longer applied to it.

Remember the academic difference when changing the specialty, be sure to "tighten the tails" in all subjects.

If the student refuses to transfer to be credited to another university, corresponding to the standards of "On Education", the leadership for its further fate is not responsible. He will have to write a written refusal, after which you can safely go to the "free swimming" in search of yourself in this life.
